

- Dividend for 2018 - adopted by the Ordinary General Meeting pursuant to Resolution No. 6/2019 of the Issuer's Ordinary General Meeting on the distribution of profit for 2018, adopted on 11 June 2019. The profit earmarked for dividend payment amounted to PLN 2,180,369.75 [two million one hundred and eighty thousand three hundred and sixty nine zloty 75/100], which was PLN 0.83/share. The dividend date was 4 July 2019, the dividend payment date was 25 July 2019. There were 1,314,870 shares of the company covered by the dividend.
- Dividend for 2018 - adopted by the Extraordinary General Meeting pursuant to Resolution No. 4 of the Issuer's Extraordinary General Meeting on the payment of dividends from the undistributed part of the 2018 profit, adopted on 16 December 2019. The dividend amounted to PLN 1,775,074.50 [in words: one million seven hundred and seventy-five thousand seventy-four zlotys 50/100], which was PLN 1.35/share. The dividend date was 30 December 2020, and the dividend payment date was 8 January 2021. There were 1,314,870 shares of the company covered by the dividend.
- Dividend for 2020 - adopted by the Ordinary General Meeting pursuant to Resolution No. 6/2021 of the Issuer's Ordinary General Meeting on the distribution of profit for 2020 and payment of dividends from retained earnings accumulated in the Reserve Capital, adopted on 23 June 2021. A total of PLN 4,168,137.90 [in words: four million, one hundred and sixty-eight thousand, one hundred and thirty-seven PLN 90/100], which amounted to PLN 3.17 per share, was earmarked for dividend payment. The dividend date was 01 September 2021, and the dividend payment date was 08 September 2021. 1,314,870 shares of the company were covered by the dividend.
- Dividend for 2021 - adopted by the Ordinary General Meeting pursuant to Resolution No. 6/2022 of the Issuer's Ordinary General Meeting on the distribution of profit for 2021, adopted on 14 June 2022. The profit earmarked for dividend payment amounted to PLN 4,094,610.00 [in words: four million ninety-four thousand six hundred and ten zloty 00/100], which was PLN 3.00/share. The dividend date was 01 July 2022, the dividend payment date was 15 July 2022. 1 364 870 shares of the company were covered by the dividend.
